# **Discussion:**

#### • 18-2

- The TC discussed doing an additional phase of this project so we will see if a Research Problem Statement is submitted.
- Colin would like to get the Materials folks together to discuss the implementation of asphalt balanced mix designs at their states. Walaa will be doing a webinar on this project, so we can let the Materials staff know about it or see if Walaa will do a separate presentation for this group.
- The TC did not have many changes to the draft final report. Maina will run the final report pdf through a 508 compliance checker, since this was not in the contract.
- Maina and Kirsten will remind PIs to acknowledge NETC sponsorship of projects when they give presentations on them.

## 18-3

 The TC is interested in having a working group that would continue to meet, as the TC for 17-1: New England Connected and Autonomous Vehicles did. Emily (or the VT member) is asking FHWA if there would be Every Day Counts 5 money available to have this group keep meeting as a working group. FHWA would provide administrative support.

#### 19-1

- Alex Bardow (TC chair) has not responded to requests to review a survey that would go be state bridge engineers, as part of Task 1. Action item: Nicholas will follow up with Alex on his availability for this project.
- Action item: Kirsten will get an update on Tasks 2 and 3.

## 20-series projects

- o 20-1 ME is waiting for a cost proposal from RoadSafe.
- o 20-2 ME has a cost proposal from UMass Lowell.
- 20-3 AECOM based the project expenses on a 50-mile radius from Boston to visit three bridge sites. That radius needs to increase to 100-miles so AECOM can get into other states if the TC wants that. AECOM will resubmit their cost proposal based on the 100-mile radius.
- 20-4 Dale is doing the contract negotiations in order, so the contract with Stantec is the furthest along.
  - The cost proposal came in at \$5,000 more than the contract. The SOW of work wasn't crystal on the project deliverables, so Dale didn't negotiate this \$5,000. During the kickoff meeting, the TC and the PI need to clarify the deliverables so there is no confusion.
- Dale understands the frustration with the amount of time it takes to get projects under contract.
   He feels getting the TC members assigned, after the TAAC chooses the projects in the spring, is the key to moving the projects forward efficiently.
  - Ann A rolling Research Problem Solicitation would be a way to address this. We will see if other consortiums do this in the Re-Creating NETC project.
  - Action item: Dale will put together a timeline for the 20-series projects to see where the process might have been slowed.
- At the 1/28/20 AC meeting, Dale said that if a cost proposal is over by a few thousand dollar, he will bring it to the AC for approval.
- Re-Creating NETC Ann reminded that if the TAAC is interested in recreating NETC, they should review the surveys to ensure they cover topics now, instead of them being lingering questions later.
