- 19-3
 - Dale Transportation of beams to the UMass-Amherst lab is not included in the contract with UMass because of the overhead that would have to be added. ME doesn't allow that in their contracts.
 - Emily VT bridge project will pay for the salvage expenses, transport to the maintenance yard and transport to the lab. Have other states gone through the exercise of how to pay for this? Dale – ME is figuring it out now via their bridge program but he doesn't know the details.

- Ann Should she have heard for her TC member about this? Dale Not every state will
 provide beams. The goal to is identify and get beams from each state, but this may or
 may not happen.
- 20-series timeline review.
 - The hold up point seems to be getting TC members assigned. Once the TC has four members, CTC can schedule the SOW meetings with the TC. Dale ME can only shorten the process so much once they receive the finalized SOWs.
 - Ann Research Problem Statements have an identified TC chair. When TAAC members talk
 to SMEs about the statements, ask them to identify a potential TC member at that time.
 - Emily That was the idea with the 4/15 due date for the identification of TC members for each project. Emily likes Ann's idea.
 - Once a project is selected, Dale goes back to the SME who provided the RPS score to determine if they would be on the TC.
