Discussion:

- 21-3
 - Dale ME and UConn want different language in the contract related to indemnification, which may not be able to be resolved. Dale will follow up with ME's Director of Contracts to see what they recommend.
 - Dale is also concerned about this being a three-year study, which won't end before the pooled fund ends. He spoke to Tricia Sergeson, TPF Program Manager, and she is discouraging a threeyear contract because it could make the reconciliation of funds at the end of the pooled fund messy.
 - \circ $\;$ A state could manage the third year of the study, if necessary.
 - Colin It would be nice to see this one go forward because the initial NETC research project was

successful. This project is focused on getting to market.

4) Wrapping up the pooled fund study

- As a curtesy, should Ann send a notice out to the Policy Committee regarding the decision to end the pooled fund?
 - Ann The Advisory Committee hasn't engaged the Policy Committee the last few years, even for approval of research program. She would like to let them know that NETC is ending. How would the Advisory Committee want to go about it? Ann sends an email to the Policy Committee or each state notify their member.
 - Emily Her Policy Committee member is the DOT Secretary and doesn't know if it will mean anything to them. She has let it be known within the agency that NETC is ending.
 - Dale Has kept his boss, the Chief Engineer, know what's going on but is unsure if she has told the Commissioner.
 - Colin The announcement should be made to the chief engineers. A letter should include the reasons why the pooled fund is ending.
 - Ann Make it an official memo to the Policy Committee from the Advisory Committee and sent by CTC?
 - Colin A memo to the staff who worked with NETC is more important.
 - Andrew This would be an in-house discussion with their chain of command and would probably not reach the commissioner.
 - Andrew would like to say that if there is a state or a partnership of states, that NETC could be saved if there is enough interest. Ann will mention other ways to partner regionally.
 - Action item: Ann will draft a memo and send to the TAAC for review and comment. The memo will come from CTC to the attention of the Policy Committee written by the NETC TAAC. Ann will add a link to the Re-Creating NETC report on the website for further information on what happened.
- Emily At the January Advisory Committee meeting, not all states indicated they would commit funds to NETC if it continued. It sounds like the end of the pooled fund is more than just not having a lead state.

- Colin NCHRP The states should get together to see what the favorite problem statements are and support each other's projects. RI submitted some topics. He will send the list to the TAAC so they can support them.
