Discussion:

• 19-1

Emily – WSP has spent most of the project funds. They did a lot of modeling but the results of the data analysis does not verify that bridge engineers could do more bridges in a simplified fashion. WSP hasn't presented their analysis it in a way that's useful to the states yet. The analysis they did provide is conservative/restrictive. The researchers will need to come up with a flow chart system to indicate under what conditions they can do simplified bridges.

- Once the TC receives the amendment options, they will review and choose an option. Emily will
 present the decision to the AC at the April meeting to see if the committee will approve
 additional project funds.
- Dale This amendment might gobble up most of the extra funds. WSP needs to know they cannot spend any funds until the amendment is approved.

- Emily Stantec will repackage the draft final report because it doesn't read well.
- Action item: Kirsten will schedule a TC meeting between before the April monthly meeting on 4/28/22.
- o The project is out of funds but Stantec is committed to finishing it.

- Colin He would like this project focus on the commercialization of the seeds being produced and would like to drop the task related to plots and monitoring. Ann – The TC agreed that they want to find a seed mix they can't currently find in New England.

Also, if any state projects have built on NETC projects, let us know. **Action item:** Kirsten will follow up with all AC members to determine if/how they have interacted with NETC projects.
- Tanya developed a survey to ask people 2-months, 6-monts, year. Also, looking at how other states sharing implementation. **Action item:** Kirsten to follow up
- Action item: Kirsten will add all current projects to the implementation spreadsheet so

- everyone can be thinking about implementation as the projects move along.
- Colin Do we get information in the QPRs on project presentations? Kirsten We could change the QPR to ask for that information.

3) Wrapping up the pooled fund study – Remaining balance

- AC members to discuss ways to utilize the remaining funds prior to the end of the pooled fund on 12/31/24.
- NETC has approximately \$60,000 in unallocated funds. Depending on which direction the UConn contract goes (NETC 21-3), there could be another \$200,000 to add to this number.
 - The \$60,000 could end up going towards the amendment for NETC 19-1.

- Dale ME is putting the full amount possible towards the CTC contract.
- Ann Would short projects be too much work for ME since they are the same contracting effort? Dale – It's beginning to be more difficult to execute contracts, especially with universities.
 - This is something to consider if there is a project that everyone is passionate about. We will keep a running list of ideas.
- Dale There is also the do nothing approach. Every state would get some money back during the pooled fund closeout, which is two and half years away.
- Emily If an SME approaches a TAAC member to express interest in meeting with their peers, then NETC could make it happen. This needs to be motivated from the SMEs.
 - Kirsten Would this be advertised to the staff so they know it is an option? Emily This
 would be more if a TAAC members hears from their staff that they want to meet about a
 topic/issue. We'll see if the \$200,000 from NETC 21-3 comes through and then perhaps send
 an email to staff.
- Colin Does ME have a certain amount they can go through without a full contract? Dale would have to look into this.

RE: Closeout of TPF-5(373) New England Transportation Consortium (NETC VII)

As the result of a recent self-examination of NETC, it was concluded that the pooled fund will be closed at the end of 2024.

A NETC research project was funded in 2020 with a goal of identifying ways to improve the effectiveness of NETC. The scope of work included a Strength, Weaknesses, Opportunities, Threats (SWOT) analysis, separate surveys to gather information from NETC transportation agency managers, implementers, subject matter experts, other pooled fund consortiums, university transportation centers, and cooperative research programs, followed by a meeting of the NETC Transportation Agency Advisory Committee to discuss the findings and possible actions.

NETC was initiated in 1988 with a mission to develop and implement innovative solutions to transportation problems relevant to New England states. Although the intent still holds value, several recent exercises indicate that a high level of research implementation is not being achieved.

Maine DOT has served as the lead agency of the pooled fund since 2018 with project management and coordination services provided by CTC Associates. There are currently six (6) active projects and three (3) more under contract. No additional research topics are being considered.

As detailed in the report, there have been many opportunities and resources provided by the NETC pooled fund; however, the value of the research has decreased for several reasons including challenges with getting subject matter expert participation, generation of research needs applicable to New England, and resistance to implement research results.

For the pooled fund to continue, one state would need to step forward to lead the pooled fund. That responsibility would also include administration of the process to contract the research projects. Staff limitation in our agency research programs pose a burden on any state.

Your role on the Policy Committee has been to intercede with regional priorities or critical issues and stay attentive to the annual program developed. We've appreciated the responsibility you have assigned to us on the Advisory Committee, and we are confident, should the need arise, collaborative research in the region is still possible.
