- On Project 13-3 Phase II: Is Mike Sock willing to remain AC liaison for Phase II?
  - *Mike Sock was not very familiar with the project and had originally taken over for Colin Franco.*
- **On Project 13-3:** Should the PI wait to submit a final report to roll results of Phase II into it?
  - There was a miscommunication with whether the PI of 13-3 should produce 1 final report with results from Phase I and II, or if two separate reports were required. The SOW for both phases specifies a final report, and there is no

mention of combining the two into one. The AC decided that Hannah should email the project TAC to have them weigh in.

• On Project 17-2: The AC questioned whether they had made a final decision on which project the research team should begin with. Emily said she would reach out to the PI to check in. She will also reach out to Flavia to see if she has had contact with the PI since the project kickoff meeting.

# 4. Update on 18-series Projects

- 18-1 Development of MASH Computer Simulated Steel Bridge Rail & Transition Details
  - Three proposals were received. The TAC met on August 8<sup>th</sup> to score the proposals and selected Roadsafe LLC. All bidders have been notified of the decision. Maine is in the process of developing and negotiating the contract.
- 18-2 Framework of Asphalt Balanced Mix Design for NE Agencies
  - The RFP was posted on August 2<sup>nd</sup>. No questions were received from potential proposers. A tentative date is set for the week of September 24 to review proposals.
  - Lily said that she would send an email to Ed Naras to confirm that he is available to be on the TAC.
  - 18-3 Integration/Incorporation of Unmanned Aircraft Systems into State DOTs
    - The RFP for this project will be posted soon.
    - Dale and Deane will check in with one another on the timeline for posting the RFP.

# 5. NETC Fund Balance Update

- CT and RI have left over travel funds, \$19,021.02 and \$12,593.53 respectively.
- NETC "unallocated" balance as of July 31, 2018 \$102,759.89

- Contributions to the new pooled fund were confirmed for ME, VT, and NH. Dale said he will check with MaineDOT's finance office to confirm the transfers.

# 6. Discussion on NETC Symposium under Maine

- The working group met on August 15<sup>th</sup> and made significant progress on scoping an NETC Symposium. The group decided to hold a one-day symposium in June 2019 in NH in conjunction with the Northeast Materials Research Engineers Meeting (NEMREM). There would be 80-100 attendees representing four topic areas (three in addition to materials). The entire group would learn about NETC research at the start of the meeting and then split into individual groups to discuss their own topics.
- The working group will continue to meet to further refine the symposium details.
- It was mentioned that posters from NETC researchers may be a good addition to the symposium, however, further details will be discussed at subsequent AC meetings.
- Maina and Kirsten said that they have a draft survey and plan to send it out in the next couple of days.
