#### 2) Research Problem Statement Solicitation

- Ten Problem Statements were received from MA (3), ME (4) and NH (3) DOTs.
- Kirsten sent the statements, evaluation for and ranking sheet to the AC on 2/6/20.
- Problem Statement Ranking/Discussion meeting on 3/31/20 in Concord.
- Late project ideas:
  - Changing Winter Maintenance and Road Salt Application and Impacts Costs (ICNet idea) –
    Two yes (NH, VT) and two no (MA, RI) votes on allowing this as an RNS to be discussed. No
    vote from CT.
    - Possible options: Reject the RNS and proposer would have to wait until next year or consider accepting off-cycle projects.
    - o Greg Greg was not at the meeting but sent the following to Kirsten: "Regarding late problem statement submissions, my feeling is that we should stick to previously established deadlines; however, I would also be fine if we changed the procedure in the future to establish a deadline for preferred consideration and then accept additional problem statements on a rolling basis and issue RFPs for those if there is any remaining funding, for example, because the initial round of problem statements received by the preferred deadline did not get enough support to move forward to RFP or proposals in response to RFPs were judged as insufficient. Related to this, I personally think it makes more sense to avoid problem statement solicitation altogether and just issue calls for proposals in broad areas of interest to New England DOTs. This would reduce the time and effort involved in the procurement process and likely lead to more innovative proposals and particularly more proposals from the region's research universities."
    - Christos He would like to adhere to the deadline set in the Research Needs Statement process. It would not be fair to those who got their statements in on time. He does not want to set a precedent for late proposals. He is fine with accepting off-cycle projects as long everyone gets a chance to propose.
    - Matt How would off-cycle project proposals be vetted? Face-to-face meeting? Voting via email?
    - Ann We will see what the outcome is in on the project voting in March before deciding on off-cycle projects. She likes the idea of asking for statements on the issues that NE states are facing. Action item: Kirsten will add these topics to the March meeting.

- Rebecca Martin proposed creating an RNS for a follow up project to 15-1: Project Use of Forested Habitat Adjacent to Highways by Northern Long-Eared Bats. From Rebecca's email, "A judge finally ruled on the case of the NLEB listing yesterday and the follow up study would be very helpful at this time." Thoughts from the AC?
  - NE does not have the data they need to comply with the judge's ruling. That's why she wants to continue 15-1 to collect the proper data. This would help all states get the information they need. Ann proposes that Rebecca come to the March meeting and explain the judge's ruling and how it affects the states' compliance. Then see where the funding falls out for other projects and if there are funds leftover for this project.
    - (a) Christos Not funding a new project, but adding funds to existing project? Ann This would be a phase II to the original project. The original researcher has left NHU and we may need to find a new researcher, which makes it a bit more complicated. Sounds like it is collecting additional data applicable to NE. Christos This sounds like it is more additional work to phase I and not a phase II. If more work under an existing task, then not the same as a late project. The project is closed so it would not be adding funds to an open contract. Ann This could possibly be a QPR, continuing 15-1 data collection.
    - (b) Ann The AC is okay with Rebecca talking to the group at the March meeting. If there are funds leftover, the AC will consider this project. **Action item**: Ann will set it up with Rebecca to discuss in March.

ME will use the document for scoring the next set of proposals for project 19-3: Experimental Validation of New Improved Load Rating Procedures for Deteriorated Steel Beam Ends.

- March agenda Action item: Kirsten will send a draft to Ann/Dale and the final to the AC.
- Christos He has an agreement with the Volpe Center to run the regional peer exchange. Action
  item: Kirsten will add the peer exchange to the March meeting agenda to find dates when the
  exchange should be held.
  - Lily How long will it be? What is the focus? Christos It will be a 2-day peer exchange. The purpose is to provide suggestions to RIDOT for revamping their Research Program, including solicitations and working with local universities. They are looking to revamp their entire program that has been dormant for a few years. They haven't had a Research peer exchange for 7-10 years.
